## What We Know

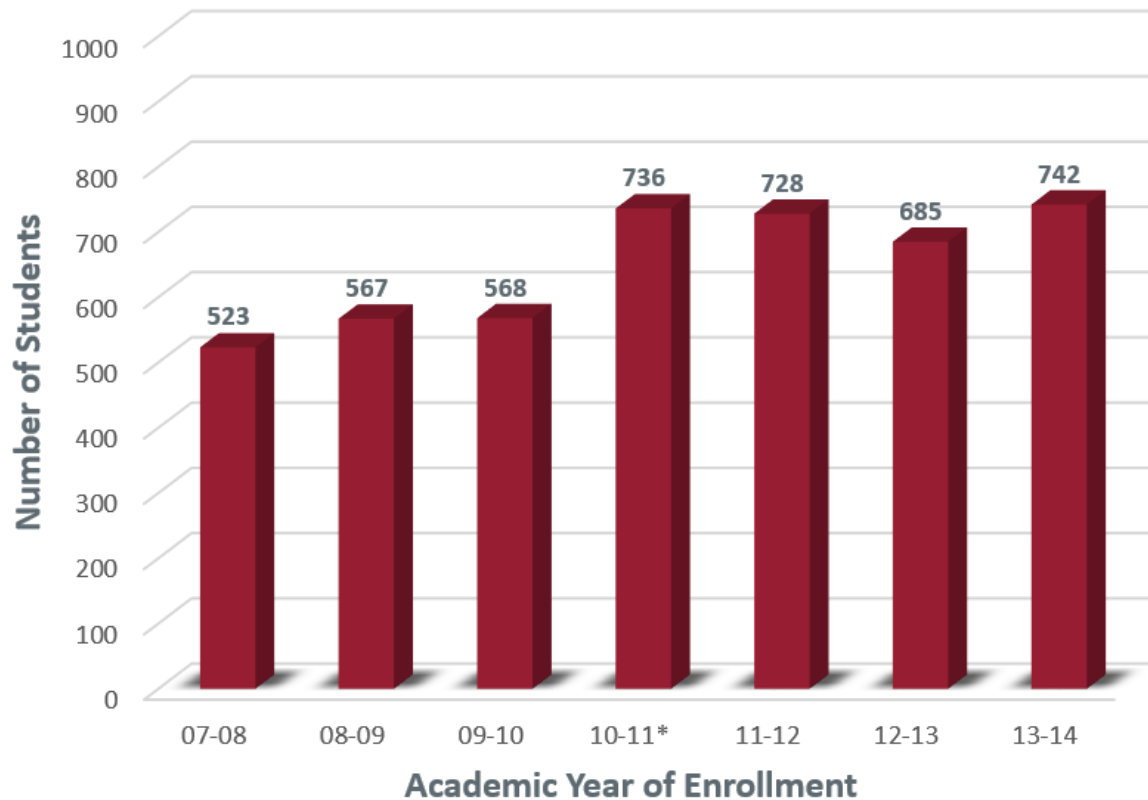
- Growth in U.S. participation abroad (Open Doors 2013)
- Increased risk for sexual assault in female undergraduates abroad (Kimble, M., Flack, W.F., Jr., Burbridge, E. 2012, October 1)
- Increased use of alcohol abroad, on average 105% (Pedersen, Larimer, & Lee, 2010)
  - On-campus 92% of claims involved alcohol (United Educators Claim Data)
- Interplay between sexual violence, substance use, and consent

## Possible Factors & Challenges

- Factors:
  - Vulnerability
  - Local culture unfamiliarity
  - Increased drinking
  - Unfamiliar surroundings
  - Similar to first semester in college
- Challenges:
  - Limited research
  - Many cultural perspectives
  - Participant perceptions
  - High number of participants
  - Self reporting

## Social Competency

- Alcohol

- The majority of sexual assault accidents occur when people participate in excessive drinking
- Drugs
- DO NOT do drugs, or even

## Sexual Assault and Risk Reduction

- Sexual assault = any sexual activity that is lacking consent.
- College women face high rates of sexual assault while studying abroad
- Risk Reduction Tips:
  - Listen to your gut
  - Make your person
  - Have a safety plan
  - Drink in moderation
  - Be a proactive

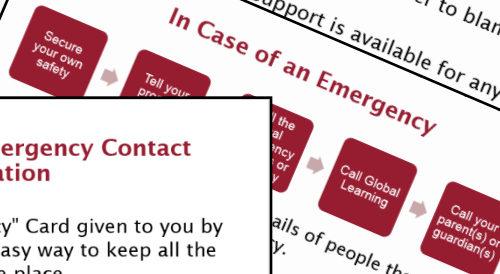
## Sexual Decision Making and Consent

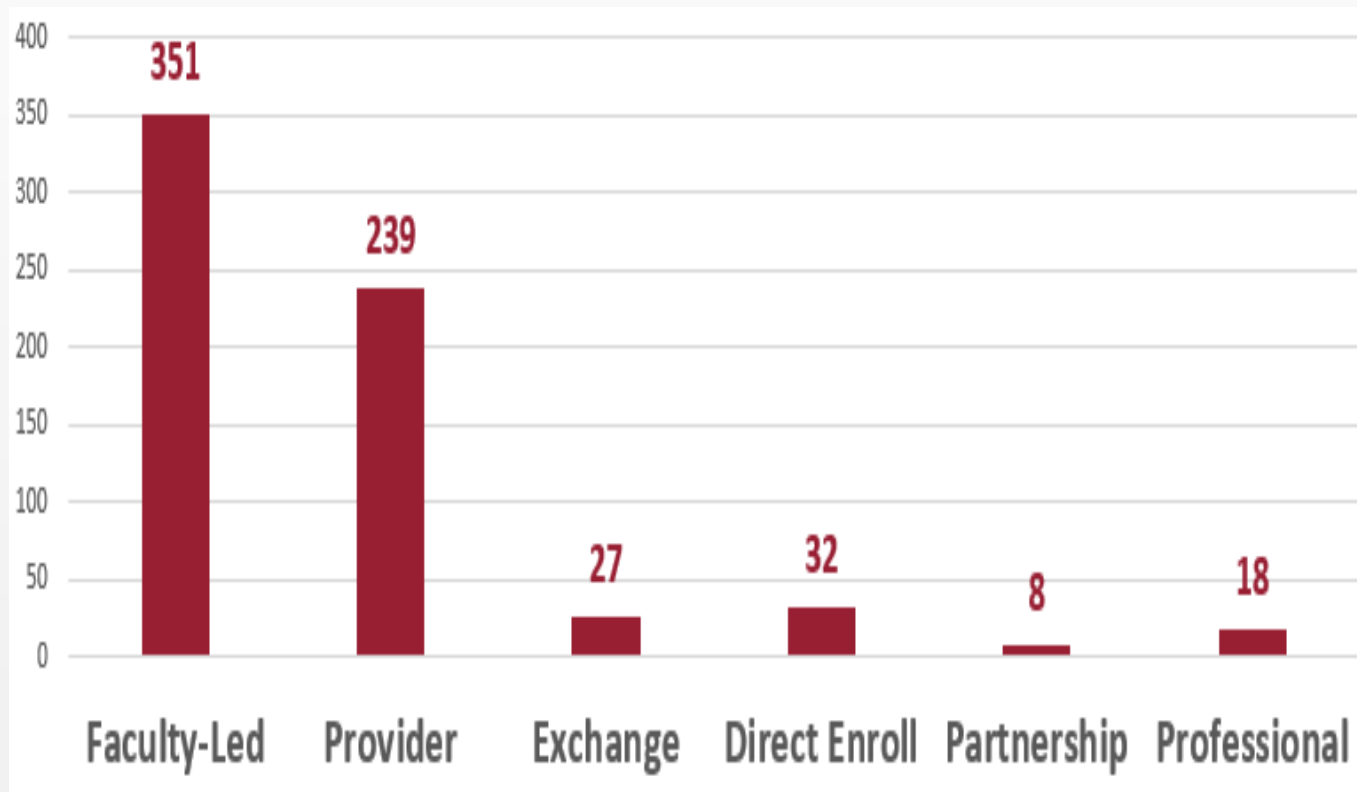

# Social Competency in Education Abroad (SCEA)

- Started in 2007
  - Continual expansion
- Initially for programs with more risky behavior
- Partnership with Alcohol & Drug Counseling, Assessment & Prevention Services (ADCAPS)
- Title IX, Clery Act & “Dear Colleague” letter
- Transformative Learning Theory (Mezirow, 1991, 2003) and Harm Reduction Theory (Dimeff, 1999)

## SCEA Curriculum

- 1 to 2 in person sessions + Online e-CHUG
- High risk health behaviors: substance use & sex
  - Challenging expectations
  - Cultural differences & laws
  - Skill and strategy development
- Framework:
  - Country specific knowledge
  - Risk taking
  - Norms clarification & perceptions
  - Problem solving scenarios



## 2012-13 SCEA Measures

### SCEA Pre- Questionnaire

- **Perceived Knowledge**- 11 questions to assess students' perceived knowledge about SCEA.
- **Country Knowledge**- 10 items measuring drinking knowledge, country of origin knowledge, & sexual norms in destination country.

### eCHUG online course & Assessment

- **Assesses**: Perceptions of drinking norms, and provides individualized feedback.

### SCEA Post- Questionnaire

- **Country Knowledge**-10 items measuring drinking knowledge, country of origin knowledge, & sexual norms in destination country.
- **Program Evaluation**- 12 questions about program evaluation & intention to change behavior.

## SCEA Results

- Effective at increasing:
  - Destination country knowledge (cultural norms, substance use, & sexual behavior)
  - Intention to be aware of situational contexts that may be risky or harmful
  - Intention to decrease and/or moderate substance use while abroad
  - Intention to practice caregiving and maintain agreed upon social contracts within the cohort prior to departure and while abroad

## WSU Preparedness

- 24/7 Emergency Contact
  - Internal Emergency Response
- Incident Report
- Risk Management- itinerary review
- Faculty training:
  - Emergency response
  - WSU Sexual Harassment & Discrimination policy
    - Application abroad
  - Incident reporting
- Affiliates:
  - Notification & reporting

## **Title IX, Clery Act & Education Abroad**

- Office of Civil Rights recommends taking preventive measures
- Title IX: Universities must take “effective corrective action” in response to sexual harassment
- Obligated to respond in accordance with Title IX and “Dear Colleague” letter on-campus and abroad

## Future

- Continue to:
  - Evaluate best delivery
  - Have WSU inter-campus collaboration
  - Maintain compliance
- SCEA:
  - During & post program surveys
- Increase faculty training
- Tabletop scenario exercise
