Dear Senior Student and Parent/Guardians,

We are writing to inform you of a new Guaranteed Admission Program (GAP) that our district is participating in. Our district is partnering with five colleges in Washington: Central Washington University, Eastern Washington University, The Evergreen State College, Washington State University and Western Washington University to offer this program.

Participating institutions require two criteria be met for a student to be eligible for guaranteed admissions: (1) a minimum GPA or minimum GPA/class ranking and (2) Completion of the College Academic Distribution Requirements (CADRs).

University cumulative GPA requirements:

- Central Washington University –3.0
- Eastern Washington University –3.0
- The Evergreen State College –2.5
- Washington State University –3.6 or ranked in top 10 percent of high school class
- Western Washington University –3.0

If a student meets the criteria or is on track to meet the criteria by high school completion, they are guaranteed admission to the institution. Students eligible for guaranteed admission must complete an admission application and additional requirements and steps by the institution.

All senior students will be opted in to the GAP Pilot unless a Opt-Out form (attached) has been completed and turned in by the designated deadline or a student has been Opted-Out via their Skyward account.

Guaranteed Admission Program Student Data Sharing Agreement

By not opting out, parents/guardians give consent for the Marysville School District to share their students educational information with the participating institutions. The purpose of this is to give the participating institutions the necessary information for use in the eligibility and admission process, including contact information. Your data will not be shared with organizations other than the ones listed below. The institutions will reach out to you directly with admission information.

Data to be Shared with Institutions:

- First & Last Name
- Date of Birth
- Mailing Address
- Phone Number
- Email(s) on record
- Unweighted GPA
- Parent of guardian contact information (e.g., email, phone)
- Class ranking
- Class ranking by percentage of graduating class
- Transcripts
- Course taking details such as course coding (e.g., Honors, dual credit)
- First generation
- Race and ethnicity
- Free and reduced-price lunch eligibility
- Additional academic and demographic data as mutually approved by the SCHOOL & INSTITUTION.

The Family Educational Rights and Privacy Act (FERPA) protects the confidentiality of all student’s education records (“Education Records”) and that San Juan Island School District may only release these records to third parties with my prior written consent or as otherwise permitted by law. Intending to waive my right to confidentiality, I consent and direct San Juan Island School District to release information from my Education Records to the organizations listed below.

Guaranteed Admission Program Opt-Out

All students are automatically enrolled to participate in the Guaranteed Admission Program. If you would like your student to opt-out of the Guaranteed Admission Program, please either opt-out via your student’s Skyward account or sign and date this form and return to the Registrar’s office by **MONDAY, DATE, 2022.**
